Due to school Closure from Covid-19, STL funding was not fully utilized according to our plan. We plan to roll this amount over and incorporate the left over amount into our future plan.

Funding Changes

1) We would look to further address our Technology needs with additional computers or tablet devices. 2) We would also look to update educational software for our computer lab. 3) We would also like to address our students behavioral needs through positive restorative intervention strategies. This would also require us to purchase additional resources for the classrooms to provide positive incentives for reinforcing positive behavior.
